AMYA Data Access Policy

1) Purpose of policy

- A. Prevent the use of AMYA member data for any purpose other than operating the AMYA or promoting the sport.
- B. Prevent the commercial use of AMYA member data.
- C. Safeguard identity and privacy of AMYA members.
- D. Policy is to be applied in conjunction with existing AMYA Privacy Policy.

2) Definitions

A. Groups

- (1) All Members: AMYA Members
- (2) Regional Member: AMYA members located within a given AMYA region
- (3) Class Members: AMYA members registered in a specific class.
- (4) **Former Class Members:** Former AMYA members who had registered boats in a specific class. (2016)
- B. Type of Access
 - (1) Lists: Either viewable on the screen or in downloadable format from the database.
 - (2) **Individual**: Viewable one at a time from the database.
- C. Information
 - (1) **Basic**: Name, AMYA #, expiration date, region, classes in which registered, and club affiliation.
 - (2) **Expanded**: Basic information and address, e-mail address, phone number, and boat registration numbers.
